**UPDATE: Oklahoma Disaster Areas Update**

**Summary:** The federal disaster declaration has been expanded to include Individual Assistance for more counties as a result of the severe storms, tornadoes, straight-line winds and flooding that began May 5, according to the Oklahoma Department of Emergency Management (ODEM) and the Federal Emergency Management Agency (FEMA).

The initial three counties—Cleveland, Grady, and Oklahoma—were previously designated for assistance under the federal disaster declaration of May 26.

The specific counties noted with an asterisk will be added to CMG's zip code list and CMG's Disaster Policy applies:
